The Town Oro Valley Police Department and Golder Ranch Fire Department are hosting the 2017 Police Explorer Academy. Explorers will be required to be registered in an Exploring Post with Learning for Life and attend all days of training to graduate.

Academy Dates: Monday thru Friday, June 19 - 30, 2017. All days 0800 - 1630 hours.

Academy Graduation: June 30, 2017 at 1800 hours located at Church of the Nazarene.

Academy / Graduation Location: Church of the Nazarene, 500 W. Calle Concordia, Oro Valley, AZ 85737.

Cost: \$75.00 per Explorer. Cost includes T-shirts, hat and training materials.

Registration Deadline: May 8th, 2017

Required Forms:

All attached forms must be completed. A Medical Practitioner must sign the appropriate form. A parent or guardian must sign required forms when the Explorer is under 18 years old. There will be daily physical fitness. Participants should be up to the challenge of strenuous activities.

Registration and fees:

The cost of registration is \$75.00 per explorer. Class size is limited to 75 explorers. Forms and registration fees are due by May 8th, 2017. This will give time for purchase of the T-shirts and training materials. You will receive a confirmation email of accepted registration.

Provided Materials:

Explorers will be issued (2) Academy T-shirts, (1) Academy Hat, training materials and ID card.
